Water Baptism and the Lord's Supper: We believe that baptism by immersion is an outward sign of the inward work of regeneration (Matt. 28:19). We believe in the commemoration of Christ's death through the partaking of bread and the juice of the vine, representing His body and blood offered for our salvation.

The Baptism with the Holy Spirit: We believe that the baptism with the Holy Spirit is given to supply the believer with power to be Christ's witness in the world (Acts 2:4).

The Spirit-Filled Life: We believe that it is the will of God that we walk by the power and the leading of the Holy Spirit daily (Gal. 5:22).

The Gifts and Fruit of the Spirit: We believe that the Holy Spirit has gifts to bestow upon the Christian and that we should show spiritual fruit as evidence of a Spirit-filled life (1 Cor. 12:1-11; Gal. 5:22).

Moderation: We believe that the experience and daily walk of the believer should never lead to extremes or fanaticism (Phil. 4:5).

Divine Healing: We believe that divine healing is the power of Christ to heal the sick in answer to the prayer of faith (James 5:14-16).

Church Relationship: We believe that it is the responsibility of believers to identify themselves with a local expression of Christ's church (Acts 16:5; Heb.10:25).

CHAPEL

All students are required to attend chapel services and are expected to participate. It is important for students to respect those who are leading.

As a ministry of New Song Nashville, NSCA's presentation of the Christian message during Chapel and in our supplemental materials will reflect that of an evangelical congregation with a charismatic distinctive. It is not our goal to alter your family's biblical or doctrinal position or to use NSCA as a means to recruit your family into New Song Nashville. We seek, singularly and without compromise, to declare Jesus Christ as Lord in all we say and do.

SCHOOL POLICIES

ADMISSIONS POLICY

NSCA partners with Christian parents seeking to enhance or extend home education. Students are selected and granted enrollment with the expectation of maintaining a high academic and moral caliber. Significant parent involvement is vital to student success. We are looking for families who will accomplish the supervision and extension of the supplementation provided, families who are active in a local, Bible-based church and families who have complied with the Tennessee Home Schooler's Law regarding umbrella school registration.

UMBRELLA SCHOOL REGISTRATION AND SCHOOL RECORDS

Parents who homeschool are considered the primary legal educators of their children, and you must be registered with an umbrella school to function legally in this capacity in Tennessee. Umbrella organizations serve the purpose of maintaining permanent records of attendance and grades for homeschooled students. In our capacity as a tutorial, NSCA's report cards become the sole property and responsibility of the parent to report to their umbrella school. Because we are not required to do so as a tutorial, NSCA does not maintain permanent student records of grades or attendance.

If you change umbrella schools or enroll in a school upon leaving NSCA, all records and attendance requests related to that change will need to go to your umbrella school. Visit MTHEA.org for further information regarding home-schooling in Tennessee.

While NSCA is not an umbrella school, we do have an umbrella school arm called Anthem Umbrella School. If you are interested in this program, visit <u>www.anthemumbrellaschool.com</u>.

PARENT PARTNERSHIP/AGREEMENT

We ask parents to support and uphold the vision of NSCA as well as the authority of the faculty and staff. Therefore, *students are not allowed to opt out of projects or assignments*.

An additional part of parental support is that we require parents to attend 2-3 mandatory meetings throughout the year, including Elementary, Middle School, High School Orientation (as appropriate) and Meet + Greet. We also ask parents to attend any needed parent/teacher conferences and volunteer their time when needed. See <u>Appendix A</u> to see a copy of the Parent Agreement you signed when you registered.

<u>It is the parent's responsibility to keep up with their student's progress</u>. Grades, syllabi and other important information can be accessed through your family's FACTS account. See the section on FACTS later in this handbook.

TUTORIAL FEES

All tutorial fee payments will be paid by bank draft unless paid in full before the beginning of the school year. Accounts will be debited on the 1st or 15th of each month (as indicated on the bank draft form of your application) for the months of August through May. If either of those days fall on a weekend, the account will be debited the following business day. A \$35 fee will be assessed to your account for any ACH debits returned as unpaid. If your ACH Debit is returned as unpaid, NSCA will re-debit your account for the tutorial fees plus bank fee within three business days after receiving the return notice. See <u>Appendix B</u> to see a copy of the Parent Agreement you signed when you registered.

ACADEMIC POLICY

We understand that each family has a different standard for learning. The NSCA family also has a corporate standard for education. Listed are a couple of the expectations that NSCA has for each student. If a student consistently does not comply with these expectations, we may

ask you to withdraw from the program.

Elementary

- Each student will commit to completing all assignments and special projects (e.g., presentations, models, etc.).
- Each student will commit to participating fully in class including taking tests, performing experiments, etc.

Middle and High School

- Each student must agree to, sign and comply with the Honor Statement and the Late Policy Covenant of Integrity documents. See <u>Appendices C + D</u>.
- Parents are expected to walk in integrity in recording grades to their umbrella school.

HOMEWORK POLICY

Our desire is that each student develops a love for learning. We believe that homework is an essential part of learning that equips students to enter into the future well. Homework constitutes a portion of the final grade that will be determined by the individual teacher. Each teacher will provide the students with a syllabus (with the exception of Study Hall and Art). Homework should be complete, on time, neat, written in pencil/pen or typed (as directed by the instructor), and legible. Your student will be taught how to properly head his or her papers. Because we are a two-day-a-week program, it is essential that the other three days of the week are spent on intentional, focused learning and work.

Incomplete or Late Work for Elementary

Students who do not have their homework completed on time according to the syllabus will receive deductions as outlined on each syllabus.

Incomplete or Late Work for Middle and High School

Students who do not have their homework completed on time according to the syllabus will receive deductions as outlined on the Honor Statement and the Homework Statement. If a Middle or High School student is missing three (3) or more assignments within a quarter in any given class, he/she will be sent to the office during lunch to eat alone and catch up on missing work. Once caught up, group lunch privileges will be restored.

Missed Work

- If a student is absent, please check FACTS for any handouts or instructions.
- If a student misses a class, he/she is responsible for finding out what was missed and what has been assigned for the next class.

GRADING SCALE

PreK-1st Grades

Progress Reports are issued at the end of each quarter. Students will be evaluated on a scale of "Outstanding", "Satisfactory", and "Needs Improvement". Further notes will be given by the teacher on the Progress Report to assess the student's subjective classroom behavior.

2nd-12th Grades

Report Cards are issued at the end of each quarter. Students will be evaluated according to the following scale:

ACADEMIC PROGRESS MONITORING

We desire to see each student progress spiritually, academically, behaviorally, and emotionally. If a student is not growing according to his or her individual abilities, we will schedule a conference between or among any of the following parties: the student, the teacher, the parents, the Director, the Campus Pastor or any other party who can help your student.

Parents are also responsible for supplementing any area of academic weakness as they see fit. For input on what this might look like, contact the appropriate division Director (Elementary, Middle, or High School).

FACTS STUDENT INFORMATION SYSTEM

FACTS gives you the opportunity to get more involved in your child's academic progress and future success—all via the internet.

FAMILY PORTAL

FACT's Family Portal (ParentsWeb) is a private and secure online portal that will allow you to view academic information specific to your child(ren). You can see your child's grades, attendance, homework and conduct, as well as other useful school information. You can also use it to contact school staff. For information on logging in, see <u>Appendix</u> <u>E</u>.

ABSENCES

Please notify the NSCA office at <u>nsca@newsongnashville.com</u> or 615/377.8037 x261 when your student is absent. Each student is an important part of our learning environment. Consistent attendance is vital to academic success and community participation. A student's learning potential is at its height if he/she is present for all classes. If a student has missed class six (6) or more times in a quarter, the teacher is unable to properly evaluate his/her participation, and an "Incomplete" will be issued. (For one-day classes, students are allowed to miss three (3) classes per quarter before an incomplete is issued.) The parents must then evaluate the student without the help of the teacher. Parents will be contacted, and a conference will be scheduled if absences become excessive.

SICK CHILD POLICY:

We do not allow children to come to New Song Christian Academy if:

- Fever has been present in the previous 24 hours
- There is green drainage from nose
- There has been diarrhea or vomiting within the last 24 hours
- There is excessive coughing due to colds, etc.
- There is any rash or skin condition unless deemed non-contagious by a physician
- There are symptoms of conjunctivitis or pink eye, such as colored discharge from the eye or red, puffy eyelids

TARDY POLICY

We believe people value others in part by valuing their time. Each student is required to be at school and in class on time. If your student is late, it hurts his/her ability to receive all that's needed, and it disrupts the learning environment for the other students. Late arrivals are also disruptive to the continuity of Chapel and Life Group, and your student misses key spiritual interaction with his/her peers. If arriving more than 30 minutes late, please notify the NSCA Office. Tardy students should enter through the NSCA office and be signed in.

Elementary

Arrival begins at **8:15 a.m.** Chapel or Life Group begin promptly at 8:30 a.m. If your Elementary student is arriving late, please enter through the NSCA Office and escort him/her to where their scheduled class is located.

Middle School

Arrival begins at **8:00 a.m.** Students must go directly to their homeroom and be present and in their seats by **8:25 a.m**. The first two tardies will be a verbal warning. On the third tardy, the student will be issued a Discipline Report. A personal contact with the parent will be made so that a pattern of consistent tardiness will not continue.

High School

Arrival begins at **8:00 a.m.** Students must go directly to their first class and be in their seats by **8:15 a.m**. The first tardy will be a verbal warning, but on the second tardy, the student will be issued a Discipline Report. A personal contact with the parent will be made so that a pattern of consistent tardiness will not continue.

PERSONAL APPEARANCE CODE

In I Corinthians 6:19, we are told that the body given to us by God is the "temple of the Holy Spirit," and that, young or old, we are to be an example to others "in word, in conduct, in love, in spirit, in faith, and in purity" (I Timothy 4:12). The message we communicate to others about ourselves and the Lord can be greatly affected by our dress. If a student comes to NSCA wearing something that violates our dress code, we will first determine if the situation can be fixed by adding an item of clothing the student may have with him/her or in Lost and Found. If it cannot be remedied, the student will contact a parent to bring something appropriate.

General Guidelines: Elementary

- Wear clothing that is comfortable for playing outside.
- Clothing must be modest, clean, neat, and properly worn.
- Blouses and shirts must not be tight, low-cut, or revealing in any way.
- Sleeveless shirts/tank tops must have straps that are at least three-fingers width.
- See-through or sheer blouses, bare midriffs or exposure of any part of the midriff are not permitted. If the shirt is cropped or tied so as to be shorter or at the waist, a shirt or tank top must be worn underneath.
- We don't allow t-shirts that promote or advertise drugs, alcohol, tobacco, have any profanity or anything not in keeping with Christian principles.
- Hair needs to be kept clean and out of the eyes.
- Leggings may be worn, but a shirt or dress that covers the student's bottom must be worn over it.
- Skirts, dresses, shorts and skorts must be of modest length, meaning the bottom of the hem must be at or lower than student's fingertips when her hands are casually at her side

General Guidelines: Middle and High School

- Clothing must be modest, clean, neat, and properly worn.
- Blouses and shirts must not be tight, low-cut, or revealing in any way.
- Sleeveless shirts/tank tops must have straps that are at least three-fingers width.

- See-through or sheer blouses, bare midriffs or exposure of any part of the midriff are not permitted. If the shirt is cropped or tied so as to be shorter or at the waist, a shirt or tank top must be worn underneath.
- Undergarments are not allowed to be seen. No exposed bra straps.
- Pants and skirts are not to be excessively tight.
- Jeans or pants with holes must have the holes be at the knee or lower unless the hole has fabric behind it so that bare skin is not seen.
- Leggings may be worn, but a shirt or dress that covers the student's bottom must be worn over it.
- Skirts, dresses, shorts and skorts must be of modest length, meaning the bottom of the hem must be at or lower than student's fingertips when her hands are casually at her side.
- We don't allow t-shirts that promote or advertise drugs, alcohol, tobacco, have any profanity or anything not in keeping with Christian principles.
- Hair needs to be kept clean and out of the eyes.
- Hats are allowed, but must be removed in the classroom if instructed by the teacher.
- Guys may not have painted fingernails or toenails.

COMMUNICATION GUIDELINES

Communication between parents and faculty:

- Faculty will respond to emails/texts/phone calls within 24 business hours (M-F, 8-5). Communication sent after 5:00 PM will receive a response after school hours the following business day unless a faculty member has the ability to respond sooner.
- Please read and follow your child's syllabus and look/plan ahead to avoid last-minute questions.
- Always check FACTS first for any documents/resources your child might be missing.

Communication between students and faculty:

- All communication between faculty and students must include the student's parent(s). Please help to reinforce this at home by teaching your kids to always include/copy you in any communication to NSCA faculty.
- If a student emails or texts a faculty member, the faculty member will only respond to the student by including the parent in the communication by starting a new text thread or by copying the parent in the email response.

DISCIPLINE AND CONDUCT

We seek to encourage and develop self-discipline in each student because it is a necessity in the maturing process and in character development. It is also necessary for the welfare of the learning environment at NSCA. It is impossible for learning to take place in a classroom unless control and good order are maintained.

Please note that, while we do have a discipline policy, we are not set up to deal with ongoing discipline issues with a student. If we have to regularly address discipline issues with your child, we will suspend the student to give him/her an opportunity to have a heart change.

STUDENT DISCIPLINE AND CONDUCT POLICY Conduct Expectations

Students at NSCA are expected to conduct themselves at all times so as to bring honor and respect to Jesus Christ, themselves, their families and to NSCA. Respect and obedience to faculty and staff are the foundation of our disciplinary code. Faculty or staff members are expected to correct students at any time for misbehavior. We discipline students for the following:

Unacceptable Behavior ("The Five Ds")

• Disruption in Class

It is important that a safe and friendly learning environment is maintained in class. Continual disruptions and distractions are grounds for discipline.

• Disrespect

Respect for authority is an important part of character development, and respect for other students is necessary for community relationships. Disrespectful speech and actions are grounds for discipline.

• Disobedience

Obedience is a quality that is pleasing to God. Each student will be expected to respond appropriately to instructions given by any adult with a good attitude. Disobedience is grounds for discipline.

• Dishonesty

Honesty is the basis of trust within relationships, and lying, stealing and dishonesty violate this basic trust. Dishonesty is grounds for discipline.

• Destruction of Property

Damaging property, whether it's personal or school property, is violating the rights of others. If damage is done to property (even accidentally), an appropriate restitution will be required and given to the owner of the property, and the action is grounds for discipline.

In addition, bullying or verbal or physical aggression will not be tolerated and may result in an immediate Discipline Report and possible suspension or expulsion.

ELEMENTARY STUDENT CONDUCT AND DISCIPLINE POLICY

Consequences for Pre-K through 1st Grade Unacceptable Behavior

The PreK-1st classrooms use a "stoplight" system of discipline. The student's name will be written next to the stoplight color they are on (green, yellow or red) to indicate the level of correction needed on any given day. The stoplight color WILL travel with the student to the next class. Parents will be notified if their student was put on the stoplight.

1. First Offense

- Verbal correction/warning Name is written next to green unless someone was harmed verbally or physically; those behaviors have Third Offense consequences.
- 2. Second Offense
 - Verbal correction Name is written next to yellow
 - Separation from group (rejoining after the teacher speaks with the student)
 - No hole punch is given on the Rewards Card for that day

3. Third Offense

- Verbal correction Name written next to red
- No hole punch is given in Rewards Card for that day
- Next lunch and recess period will be spent in the office
- Discipline Report will go home with the student to be signed by a parent and returned the next school day.
- 4. Fourth Offense

- Same consequences as the Third Offense
- The student is brought to the Elementary Director to discuss his/her repeated offenses
- Consequences issued
- Parent conference may be scheduled
- 5. Continued Offenses
 - If a pattern of unacceptable behavior continues, the parent and student will be required to have a conference with the Director and/or Pastor to create a plan of action for a change of behavior. The student will have two weeks to implement this plan. If the student does not follow the plan, he/she will be suspended for two school days. He/she will be given an additional two weeks to show improvement. If the behavior does not change, the student will be asked to leave NSCA without parents being released from the Financial Agreement.

Consequences for Elementary (2nd-5th Grade) Unacceptable Behavior

The 2nd-5th classrooms use a "stoplight" system of discipline. The student's name will be written next to the stoplight color they are on (green, yellow or red) to indicate the level of correction needed on any given day. The stoplight color WILL travel with the student to the next class. Parents will be notified if their student was put on the stoplight.

1. First Offense

- Verbal correction/warning unless someone was harmed verbally or physically; those behaviors have Third Offense consequences.
- Name is written next to green
- No NS Bucks can be received for the remainder of the day
- 2. Second Offense
 - Verbal correction
 - Name is written next to yellow
 - Student is separated from the class for a few minutes to regain self-control
 - After a few minutes, the teacher will speak to the student about their expectations in class, then rejoin the class.
- 3. Third Offense
 - Verbal correction
 - Name written next to red
 - Separation from group
 - Next lunch and recess period will be spent in the office
 - Discipline Report will go home with the student to be returned the next school day
- 4. Fourth Offense
 - Student referred to Director
 - Consequence issued by the Director
 - Parent Conference may be scheduled
- 5. Continued Offenses (see Middle School Continued Offenses below)

Middle and High School Consequences for Unacceptable Behavior

1. First Offense

• Verbal correction/warning unless someone was harmed verbally or physically or intentionally destroys property; those behaviors have Third Offense consequences.

- 2. Second Offense
 - Discipline Report is written
 - Separated lunch, plus 15 minutes of serving (wiping tables, sweeping, picking up trash, etc.)
 - Student may be referred to their Division Director
- 3. Continued Offenses
 - Probation: Three (3) or more Discipline Reports in a semester.
 - If a pattern of unacceptable behavior continues and/or three Discipline Reports have been issued within a school year, the parent and student will be required to have a conference with the Director and/or Pastor to create a plan of action for a change of behavior. The student will be considered "on probation" for six (6) weeks.
 - Suspension: An additional Discipline Report during probation.
 - If the student receives a Discipline Report within the six weeks of probation, they will be suspended from school for two (2) days and given extra work to do at home during that time.
 - During suspension the student will receive zeros for all missed work.
 - Expulsion: An additional Discipline Report after returning from suspension.
 - After returning from suspension, if the behavior does not change or the student receives another Discipline Report, the student will be asked to leave NSCA without his parents being released from the Financial Agreement.

There are rare exceptions for all students when an immediate dismissal may be implemented. It is important to the entire student body that a safe and Christ-like environment be maintained.

BULLYING POLICY

New Song Christian Academy has a zero-tolerance bullying policy, and we do not condone or allow bullying of others. Any student who believes he or she has been subjected to bullying should report these actions immediately to a faculty member or Division Director. We are committed to providing an environment in which every student is treated in a respectful manner that honors God and one another. Conduct, whether intentional or unintentional, that subjects another student to unwanted attention, comments or actions is not permitted.

CAMPUS SAFETY POLICY

NSCA has a zero-tolerance policy regarding weapon possession and threatening communication/speech.

- NSCA does not tolerate weapons at any time on school grounds, school events, or transportation to and from school events. Any student found to possess, store, handle, transmit or use any weapon would be subject to administrative and/or legal action.
- Students who become aware of a weapon being brought to school or on school property must immediately notify a faculty member.
- Definition of a weapon: A weapon is defined as a knife, firearm, or an item which looks like a firearm, whether loaded or unloaded, destructive explosives or any look-alike or any other device that is meant to threaten, intimidate or produce bodily harm or fear of such. Examples of weapons include, but are not limited to: All firearms, other firearms

including BB/pellet/look-alikes; knives, including switchblades and Swiss army knives; knuckles, martial arts devices, explosives, slingshot, mace.

- Consequences: Possession of a weapon will lead to suspension and the immediate initiation of the expulsion process and may lead to a referral to the police.
- Making a fake threat of violence is a criminal act that can land you in prison. It doesn't matter if you say it, text it, write it, "snap" it or post it on social media, students who make threats can face serious consequences.
- Every violent threat is taken seriously, because police don't know if a threat is real or fake.
- We reserve the right to search personal property (backpacks, purses, jackets, etc.).

NEW SONG BUCKS (ELEMENTARY)

NSCA does not use candy as a reward in elementary classes. Instead, we have a system where teachers give "New Song Bucks" as a reward for winning a game, a contest, helping with cleaning, doing something above and beyond without being asked, etc. Students should write their name and grade on the buck when it is rewarded.

- When Elementary students earn 35 New Song Bucks, they bring them to the office and can select from the New Song Bucks items in the office. Students may shop <u>before and after</u> school only.
- New Song Bucks are not to be used as currency for student-to-student transactions but are to be reserved for teachers' use and are only to be spent on items we have available for "purchase" in the office.

CAMPUS POLICY

We are committed to keeping our campus and students safe.

SCHOOL HOURS

- Elementary classes are in session from 8:30 a.m. until 2:00 p.m. or 2:45 p.m., depending on the electives chosen.
- Middle School classes are in session from 8:25 a.m. until 2:45 p.m. or 3:45 p.m., depending on the electives chosen.
- High School classes are in session from 8:15 a.m. until 2:45 p.m. or 3:45 p.m., depending on the electives chosen.

ARRIVAL AND DISMISSAL PROCEDURES

We have two buildings at New Song Nashville: The Learning Center (where the NSCA office is located) and the Worship Center (where the Celebration Room is located). See <u>Appendix F</u> for Arrival and Dismissal map. The Learning Center and the Worship Center doors will be locked during the day except during Arrival and Dismissal; during that time, the NSCA Office is not to be used by families dropping off. The NSCA Office entrance will be used at all other times.

Arrival

Elementary

- The Learning Center double foyer doors will be unlocked at 8:15 a.m. Families will not be allowed in the building before that time. Students arriving before 8:15 a.m. are not to be left in the parking lot unattended.
- Parents will receive a placard with their last name to put on the dashboard of their car

to help assist those directing traffic to identify vehicles entering the NSCA parking lot.

- Parents may drop students off at the Learning Center foyer doors (left two lanes only) or park and escort them into the building.
- Once admitted to the building, students must go to their homeroom and are not allowed to roam the campus freely.

Middle School

• Students may be dropped off as early as 8:00 a.m. at the glass doors on the east side of the Worship Center. Students must go to their homeroom and are not allowed to roam the campus freely.

High School

- Students may be dropped off as early as 8:00 a.m. at the Learning Center Foyer doors.
- Students must go to their First Period class and are not allowed to roam the campus freely.

Dismissal

Elementary

- Elementary students will be picked up at the Learning Center foyer doors. A faculty member will announce students' names through our radio system, which will alert each teacher in grades PreK 5th to send those students to the foyer doors to be picked up.
- PreK 1st parents may begin arriving at 1:55 p.m. to pick up their students who are not taking electives.
- 2nd 5th parents may begin arriving at 2:00 p.m. to pick up their students who are not taking electives.
- Students will be supervised in their homerooms until 2:10 p.m., then all remaining students will go to the office. Late fees of \$5 every 15 minutes per vehicle will be assessed beginning at 2:10 p.m. Unpaid late fees will be added to the family's tutorial fee balance.
- Once a student has been picked up by the authorized person, they MUST remain within arm's reach of that adult. Students are NOT allowed to roam freely at any time while on our property, including the parking lot.
- Students are not allowed on the playground without an NSCA staff member present.
- If a student is to be dismissed to walk to Roots Academy, parent must notify NSCA by emailing Danielle Caveny at <u>dcaveny@newsongnashville.com</u>.

Middle School

- All Middle School students are to be picked up by an authorized driver.
- Late fees of \$5 every 15 minutes per vehicle will be assessed beginning at 3:00 p.m. or 4:00 p.m., depending on the student's class schedule. Unpaid late fees will be added to the family's tutorial fee balance.
- If a student is to be dismissed to walk to Roots Academy, parent must notify NSCA by emailing Brenda Beiden at <u>bbeiden@newsongnashville.com</u>.

High School

- All High School Students are to be picked up by an authorized driver.
- Late fees of \$5 every 15 minutes per vehicle will be assessed beginning at 3:00 p.m. or 4:00 p.m., depending on the student's class schedule. Unpaid late fees will be added to the family's tutorial fee balance.
- If a student is to be dismissed to walk to Roots Academy, parents must notify NSCA by emailing Cindy Wagner at cwagner@newsongnashville.com.

STUDENT DRIVERS

Student drivers must be registered with the NSCA office and will receive a placard for their dashboard and a tag for their keyring.

- Upon arrival, the student driver will sign in on the Driver Sheet and turn in their keys.
- At dismissal, the student driver will sign out on the Driver Sheet and receive their keys back. The student driver must then leave the campus.
- Student drivers cannot take any riders with them unless the NSCA has first received permission directly from both sets of parents.
- Student Drivers must keep their NSCA tag on their keyring and placard in their car throughout the school year.

PARKING POLICY

Parking is only allowed in designated spaces (clearly-painted lines) on our campus. If you are unable to find parking in our lot, you must park on the street.

- Help us be good neighbors by not parking in anyone else's lot nor blocking entrances to their lots.
- Respect the traffic cones and traffic assistants; it keeps you moving as quickly and safely as possible.
- Abide by the campus speed limit: 5 mph (it's slower than you think!).
- Follow the posted entrance and exit signs for parking lot flow. ALWAYS be watchful for children crossing the parking lot.
- Handicap parking is ONLY for those who are legally allowed to park in handicap spaces.
- Students and any other children with you must remain within arm's distance of you at all times.

WEATHER CLOSURE PROCEDURES

NSCA **DOES NOT** follow any public schools for weather closures. We will announce closings via FACTS Parent-Alert and on our Facebook page.

CLEANING POLICY

We believe every family member should participate in family chores. Along those lines, we also believe that students will gain a higher level of respect for the NSCA facility when they help maintain it. We ask that students participate in the basic cleaning (picking up trash, wiping down tables, etc.) of the NSCA facility as needed.

KITCHEN/FOOD POLICY

- Students are not allowed to use the kitchen in the NSCA Office, neither to store their lunches nor use the microwave.
- Students should have their own cutlery, napkins and drinks. If no drink has been provided, the student may get a small dixie cup during lunch from the NSCA Office for water to be filled at the water fountain.
- Middle School students who have forgotten their lunches will be encouraged to share with peers. (Sharing lunches is not allowed in Elementary due to the potential for allergy contaminants.) Students without lunches may also choose two to three non-perishable snacks from the NSCA office for \$2/student.
- Students are not allowed to "snack" out of their lunch boxes during class unless they have a documented medical condition.
- For the safety of all of our students, NSCA is a nut-free facility (see "Allergy Policy" below). If a student brings any nuts, including nut butters, packs of nuts, candy bars with nuts, etc., in their lunch or as a snack, it will be thrown away. If it is the student's main lunch item, a microwavable meal will be prepared and given by a teacher. The parent will be notified any time we find nuts or nut products brought to school.

- PreK-1st Grade will have a story and snack time in the afternoon when they are allowed to "snack" from their lunches.
- Nut-free candy may be enjoyed at lunch but should not be brought into the classroom.
- Water bottles (labeled with name and grade) are encouraged. They may be refilled from our filtered drinking fountains between classes. DO NOT bring glass water bottles to school. Students may only drink water during class; they may not have coffee, tea, sports drinks, sodas, etc., except during lunch. Energy drinks are not allowed at any time.

CELL PHONES AND ELECTRONICS POLICY

Cell Phones

Elementary and Middle School students are not to carry or use cell phones on campus for any reason at any time, including during lunch, during special events, or in restrooms. If parents require their child to have a cell phone with him/her, it must remain in the student's backpack and turned off (not just on vibrate) and must remain there until the student is off NSCA property. If parents and students need to make contact during the day, they may use the NSCA office line. If a student is caught carrying a cell phone (even in his/her pocket) or using it, the phone will be confiscated and brought to the NSCA Office for the parent to pick up at the end of the day, and a Discipline Report will be issued.

High School students will turn in their cell phones upon arrival and pick them up at dismissal.

Electronics

- Students are not allowed to bring cameras, iTouches, iPads, smart watches, e-readers, electronic notebooks, computers or video games unless given specific permission from a teacher for a specified reason.
- Students are not allowed to bring laptops unless it is for a class presentation and has been pre-approved by their instructor.
- If found, all electronics will be brought to the NSCA Office for the parent to pick up at the end of the day, and a Discipline Report will be issued.

NO WHEELS ON CAMPUS AND NO EXTRA ITEMS

For the safety of our students, we will not allow anything on campus that could cause harm.

- Skateboards, scooters, roller blades or shoes with wheels are not allowed.
- Musical instruments, overnight bags and class projects may NOT be left in the office.

LOST AND FOUND

- Lost and Found items will be placed on our "Lost and Found" cart. During the school day and school week, the cart will be in the Learning Center Foyer. Over the weekend, the cart will be in the NSCA Office.
- It is the student/parent's responsibility to retrieve their lost items.
- Although we attempt to bring found items to the NSCA Office, there is no guarantee a lost item will be retrieved.
- Unclaimed Lost and Found items will be donated after 30 days.
- We recommend parents label all of your student's belongings and check Lost and Found on a regular basis.
- Class projects may not be stored on-site between class days. Forgotten projects or class work will be thrown away after 48 hours.

STUDENT MEDICATIONS

• All prescription medication(s) students are required to take during school hours must be stored in the NSCA office and administered by an NSCA faculty member.

ALLERGY POLICY

WE ARE A NUT-FREE FACILITY.

- If your child has allergies, you should explain the extent of them in writing on the application and what precautions need to be taken. If your child has a food allergy, you may also keep "special occasion" snacks in their backpack or in the office freezer.
- All class snacks or food products for a class presentation should be completely nut-free.
- We cannot have, under any circumstance, bags of loose nuts (shelled or unshelled).
- Items found with nuts, nut butters or any snack with nuts or nut products will be thrown away.
- Students with nut allergies will be exempt from cleaning the lunchroom.
- If your student needs special medications for allergic responses, seal them in a labeled plastic storage bag with full instructions and turn them in to the NSCA office.
- If your student has an Epi pen, you may bring it to the office for safe keeping in our medical cabinet or keep it in the student's backpack. Seal it in a plastic storage bag with a note card inside including the student's full name and age, your full name, your phone number and your student's allergies. PLEASE NOTE: Every time we administer an Epi pen, we are REQUIRED to call 911. Parents will be notified immediately as well.
- It is the parent's responsibility to make sure any Epi-pen stored at NSCA for their child is current and not expired.

Although it is not a requirement, we believe that teaching the skills to take standardized tests is valuable. While you are free to choose which years to test your student(s), we recommend you consult your umbrella school to determine the best path for your family.

PARENT AMBASSADORS (PA)

The Parent Ambassador program was developed to help homeschooling parents connect with one another. Homeschooling can be extremely rewarding and overwhelming and isolating all at the same time. Our heart for the PA program is that the parents make true connections with other families during their time at NSCA.

Parent Ambassadors are volunteer parents who serve both our parents and staff. They will coordinate class parties, field trips, closed Facebook groups, and parent get-togethers to cultivate stronger community at NSCA. They work in partnership with NSCA staff to help keep parents updated with events as well.

FREQUENTLY ASKED QUESTIONS

HOW DO I ACCESS MY CHILD'S CLASSROOM RECORDINGS FROM HOME?

Classes will be recorded and posted to our home page on Vimeo.com. You can locate the classroom recordings at vimeo.com/newsongchristianacademy. A few things about these videos:

- Teachers typically begin uploading their videos at the end of each class period. This upload time may vary but typically you should be able to access the video within 10-15 minutes following each class period.
- The videos are password protected for privacy. The password for the 2023-24 class recordings is Acts2024.
- These recordings are meant to capture what happens in class each day at a fairly broad scope with the primary focus being what is being said by the instructor. Notes being written on the whiteboard may not be visible on the video, so we encourage students to reach out to the instructor if they miss and need that information.
- We ask that the links, videos, and passwords not be shared with anyone outside of NSCA.
- There is a chance that these videos will capture students' voices and sometimes their images, depending on the class activity.
- Remember, there are a few exceptions for class recordings. For example, project-based classes and test days are not recorded. Please reference each teacher's "Learn from Home" document found in FACTS.

HOW DO I HELP MY MIDDLE SCHOOL CHILD BECOME AN INDEPENDENT LEARNER?

One of the biggest goals in Middle School is helping your child become an independent learner. In the 6th grade, we recommend helping your child plug all of their assignments

into a centralized calendar or planner. You will most likely need to help your child do this during the 6th grade. In 7th grade, he/she can begin to plan their own workday with your supervision. We encourage continuing to use a student planner throughout all of middle school. By the time your child reaches 8th Grade, he/she should be able to plan out most of their workload with only minimal assistance from the parent. We recommend the daily Student Planner from wellplannedgal.com.

WHAT HAPPENS IF WE HAVE TO MISS SCHOOL?

- Students are responsible for reading their syllabus to see what assignments they have missed during their classes. Teachers have specific guidelines for turning in late or missing work.
- Teachers will load any worksheets from that missed school day onto FACTS.
- A parent should email an instructor if a test was missed during the class to arrange a time to make it up or take it at home.

WHAT SHOULD WE DO WITH LATE HOMEWORK?

- Late work results in points deducted, so check with each instructor's syllabus for more specific details.
- If you have late homework, you may put it in the teacher's mailbox located in the NSCA office. You may also have your student hand in the work to the teacher at the following class.

HOW CAN I ORGANIZE ALL OF MY CHILDREN'S NSCA SCHOOLWORK?

Start a filing system at home. Don't throw away all of your child's work when it comes home throughout the year; keep it even after the school year is complete. If you were to stop homeschooling and transfer to another school, some schools require you to produce the work your child has done. Also, in the unlikely event that you are ever audited, it will be very easy to have your student's work on hand.

WHAT IF MY CHILD NEEDS EXTRA HELP AT SCHOOL?

NSCA has Skill Building Aids who work with the students who need support for different challenges like dyslexia, high-functioning autism, reading comprehension, and anxiety. They can also help students by administering tests in a quiet area for less distractions, verbal testing, helping students stay on task in the classroom, taking notes for younger students, implementing organization, and giving encouragement. If you would like more information on Skill Building, contact your Division Director. Skill Building help is an additional cost on top of tutorial fees.

HOW DO I BALANCE ALL OF THE PROJECTS IN ADDITION TO THE REGULAR HOMEWORK AND MY OWN CLASSWORK?

The syllabus is a great tool to use when you are planning out your quarter. Plan out how many days you predict it will take to finish a project, then schedule what part of each project your student will accomplish each homeschool day. If you have two projects or tests due the same week, you may need to start working on one project even earlier. Sometimes Saturdays are good days to tackle projects you don't have time for during the week.

SHOULD I HOMESCHOOL IN THE SUMMER?

NSCA starts in mid-August and finishes early May, which is about a 3½-month break. Some parents choose to take the summer completely off from homeschooling. Others may choose to take a short break and then take the opportunity to work on subjects that either were challenging the previous year or that you anticipate being challenging the coming year. It's a good time to teach subjects that you may not be able to cover during the year, e.g., typing. Some Elementary parents start teaching a few days a week in July with spelling and math (this is especially helpful for parents who are teaching five-day-a week curriculums). Summers are also a good time to take field trips that you haven't had a chance to experience during the school year.

WHAT SHOULD MY CHILDREN READ OVER THE SUMMER?

We recommend children continue to read year-round. For older children, we especially recommend not just any books but good books—books centered around the Bible, classic books and books that speak to any issues or challenges they may be facing. If you have a child who is dyslexic, find a series that they really like and read all the books in the series. As reading becomes easier, give them specific books to challenge them. Audio books are also great for a struggling reader; they get to enjoy the book by listening and reading along instead of laboring over words.

APPENDIX A: PARENT AGREEMENT

Parent Agreement

Umbrella Information

NSCA students must be registered with a valid, State of Tennessee-approved umbrella school per the Tennessee Home School law (Tennessee Homeschool Annotated 49-6-3050). The State of Tennessee requires all students between the ages of 6 and 18 to be enrolled with an umbrella school. NSCA is not an umbrella school and does not maintain permanent records or provide standardized testing. As such, you, the parent(s), are responsible to keep permanent records and make arrangements for standardized testing for your child(ren). Progress reports issued by NSCA become the sole property of the parent. It is the parent's responsibility to report all educational information to the umbrella school.

Release Form

In the event my child becomes seriously ill or injured while on the New Song Nashville (NSN) campus or while attending a related event, I agree that the NSN authorities shall first make an effort to contact the responsible parent or guardian. If the student's parent or guardian cannot be reached or if NSN authorities believe my child's condition requires emergency medical attention, NSN authorities will use their own discretion in contacting a properly licensed and practicing physician and will follow his/her instructions. If, in the opinion of a properly licensed practicing physician, my child needs medical or surgical services which require my consent before being supplied and I cannot be reached, I hereby authorize, appoint and empower the NSN authorities to furnish on my behalf such written or oral authorization as may be required. Further, I release the NSN employees, trustees, New Song Nashville and New Song Christian Academy from any liability which may arise from the giving of such authorization, it being my desire that my child be furnished with such medical or surgical services as soon as reasonably possible after the need arises. I understand that NSN is not an allergy-free environment. I

understand that Epi Pens will be administered by NSN staff or parent volunteers because no registered nurse is on campus. I grant permission for my child to be on campus and attend all off-site events, and I grant permission for my child to be allowed to ride in a vehicle of another parent or staff member without liability to the driver, to NSN and its staff. The image or voice of my child may be published in yearbooks, school web-sites or printed materials without liability.

APPENDIX B: NEW SONG CHRISTIAN ACADEMY FINANCIAL AGREEMENT

New Song Christian Academy has a number of ongoing expenses, such as faculty and administrative salaries and supplies. In order to maintain these services throughout the year, it is essential that NSCA's annual income from tutorial and other fees be consistent based on people's commitment to the program. Because of this, we have established the following policies:

Fees

- Students registering before June 15 must pay the New Student Application and Registration fees at the time of registration.
- Supply Fees may be paid between the time of registration and June 15. Any fees not paid by June 15 will be automatically drafted from your account on June 15.
- Students registering after June 15 must pay New Student Application, Registration, and Supply fees at the time of registration in order to be enrolled.

Mid-Year Enrollment

- Students enrolling in August, September and October:
- Pay full Supply Fees, which are due at the time of registration
- Pay the full yearly Tutorial Fees amount distributed evenly over the months remaining until the end of the school year
- Students enrolling in November and December:
- Pay full Supply Fees, which are due at the time of registration
- Pay prorated yearly Tutorial Fees amount distributed evenly over the months remaining until the end of the school year
- Students enrolling after Christmas Break:
- Pay half Supply Fees, which are due at the time of registration
- Pay prorated yearly Tutorial Fees amount distributed evenly over the months remaining until the end of the school year

Tutorial fees Payments

- Automatic Bank Draft (ACH Debit) is required for monthly tutorial fees payments. Drafts will be processed on your choice of either the 1st or 15th of each month (August through May).
- Any bank fees incurred by NSCA for ACH Debits returned as unpaid will be assessed to your customer account.
- If your ACH Debit is returned as unpaid, NSCA will re-debit your account for the Tutorial Fees plus bank fee within three business days after receiving the return notice.

Student Early Withdrawal

• If a student withdraws before the NSCA school year begins, school fees already paid (Application, Registration, Supply and Tutorial fees) are non-refundable.

- If a student withdraws after the NSCA school year has begun but on or before Oct. 31, 75% of the remainder of the first semester (August December) Tutorial Fees will be due.
- If student withdraws on or after Oct. 31, 75% of the remainder of the full year Tutorial Fees (August-May) tutorial fees will be due.

Pre-paid Tutorial Fee Refunds

- If a student withdraws before August 1, 75% of pre-paid Tutorial Fee is refundable.
- If a student withdraws between August 2 and beginning of the NSCA school year, 50% of pre-paid Tutorial Fee is refundable.
- If a student withdraws after the NSCA school year begins, pre-paid Tutorial Fee is non-refundable.
