Financial Agreement

New Song Christian Academy has many ongoing expenses, such as faculty and administrative salaries and supplies. To maintain these services throughout the year, it is essential that NSCA's annual income be consistent based on people's commitment to the program. Because of this, we have established the following policies:

Fees

- New Students must pay the New Student Application and Registration fees at the time of registration.
- Returning Students must pay the Registration fees at the time of registration.
- Deposit will be automatically drafted from the account provided on the Enrollment application on June 15 or the first business day after that.
- Students registering after June 15 must pay New Student Application (as applicable), Registration, and Deposit at registration.

Mid-Year Enrollment

- Students who enroll after classes begin through December 31 will pay the full year's Deposit and Tutorial
- Students enrolling after December 31:
 - Pay half of the Deposit, which is due at the time of registration;
 - o Pay half of the yearly Tutorial Fees.

Tutorial Fees Payments

- Tutorial Fees are yearly amounts but may be broken down into 10 monthly payments.
- Automatic Bank Draft (ACH Debit) is required for monthly tutorial fees payments. Drafts will be processed on your choice of either the 1st or 15th of each month, August through May.
- A \$35 fee will be assessed to your customer account in the event of a returned ACH debit.
- If your ACH Debit is returned as unpaid, NSCA will re-debit your account for the Tutorial Fees plus bank fee within five business days after receiving the return notice.

Student Early Withdrawal

- If a student withdraws before the NSCA school year begins, school fees already paid (Application, Registration, Deposit and Tutorial fees) are non-refundable.
- If a student withdraws after September 1, all fees paid are non-refundable, and the remainder of the full year's Tutorial fees will be due, including all Electives (Elementary, Middle School, High School and Fine Arts).
